

## The Medical Council of Canada Research in Clinical Assessment - Grant application checklist -

### Eligibility

- Do you hold an appointment at a Canadian medical school, health science faculty or research institute at a teaching hospital?
  - If no, do you have a letter of support from a supervisor that holds the above appointment?
- Is your proposal related to medical education research/clinical assessment?

***If the answers to any of the above questions is 'NO', you ARE NOT eligible for the Research in Clinical Assessment grant competition.***

### Themes

- Proposals should focus on one or more of the following themes:
  - Outcomes measurement and predictive measurement (e.g., association between assessment results and future performance in practice)
  - Assessments along the continuum of a medical career (e.g., undergraduate, postgraduate, in-practice, etc.)
  - Improving feedback from assessment results (including both summative and formative assessments).
  - Measuring critical and emerging competencies in medicine
  - Role and use of technology in and for assessment

### Award Details

- Is your budget equal to or lesser than the maximum funding amount of \$37,500?
- Are dissemination costs capped at 10% of the total requested funds (e.g., up to \$3,750 if the total project budget is \$37,500)?
  - Are conference related costs limited to one conference (capped at \$2,500)?
  - Have you included a statement of how attendance at this conference aligns with one or more of the four research themes (referenced in section 3 of the call for proposals)?
- Are transcription costs capped at \$150/hour of audio?

***If the answers to any of the above questions is 'NO', please amend your proposal prior to submitting.***

### Proposal Preparation
